## BASIS FOR QUALIFIED OPINION ON FINANCIAL STATEMENTS

With respect to the company's investment property having a carrying amount of £3.4 million, the evidence available to us was limited. The directors of the company have complied fully with the requirements of accounting standards in respect of this property and have valued the investment property to the best of their ability, at open market value as required by SSAP 19. However, in the current market conditions, we are unable to make an assessment of the accuracy of this valuation. Owing to the unstable nature of the current property environment, although the directors have valued the property held to the best of their ability, there is no active market from which we could make an assessment of its open market value and we were unable to obtain sufficient appropriate audit evidence regarding the valuation of the investment property by using other audit procedures.

## **QUALIFIED OPINION**

In our opinion, except for the possible effects of the matters described in the Basis for Qualified Opinion paragraph, the financial statements:

- Give a true and fair view of the state of the company's affairs as at 31 March 2015 and of its profit for the period then ended;
- Have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice; and
- Have been prepared in accordance with the requirements of the Companies Act 2006.

## 1. ACCOUNTING POLICIES

## **Basis of accounting**

The financial statements have been prepared under the historical cost convention, and in accordance with applicable UK accounting standards.

#### Cash flow statement

The directors have taken advantage of the exemption in Financial reporting Standard No 1 (Revised 1996) from including a cashflow statement in the financial statements on the grounds that the company is small.

#### Turnover

Turnover represents the total amounts derived from rentals receivable, net of vat, on lettings to tenants accrued on a time basis, by reference to the agreements entered.

## Fixed assets

All fixed assets are initially recorded at cost.

## **Investment properties**

Investment property is revalued annually, surpluses arising thereon being credited to an investment revaluation reserve. Deficits arising are charged to the profit and loss account if not exceeded by previous revaluation surpluses.

No depreciation is charged on investment property. This constitutes a departure from the statutory rules requiring fixed assets to be depreciated over their useful economic lives and is necessary to enable the financial statements to give a true and fair view, in accordance with Statement of Standard Accounting Practice No. 19 - Accounting for Investment Properties.

## Financial instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into. An equity instrument is any contract that evidences a residual interest in the assets of the entity after deducting all of its financial liabilities.

## 1. ACCOUNTING POLICIES (continued)

## Corporation tax

Corporation tax is calculated on the results for the period.

Tax deferred as a result of timing differences between accounting and taxation profits is provided in full in respect of deferred tax liabilities with the exception of differences arising from the revaluation of the fixed assets, where there is no binding agreement to sell the asset at the balance sheet date and where the gain or loss on such a sale has not been recognised in the financial statements. The provision is made at the taxation rates at which the timing differences are expected to reverse, based on tax rates and laws that have been enacted or substantively enacted by the balance sheet date. Deferred tax assets are recognised to the extent that they are regarded as recoverable.

Tax losses are surrendered between group companies for no consideration.
