

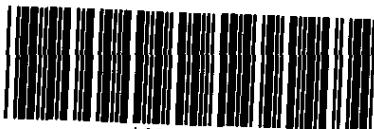



The Sheriff, having considered the petitioner's application to restart the cause, number 3 of process, Grants the same, whereby, resumes consideration of the foregoing petition together with the productions produced, and having seen the Edinburgh Gazette published between 6 and 12 May 2020 and the Herald newspaper dated 14 May 2020 each containing the intimation ordered by the preceding interlocutor, no answers to said petition having been lodged in court, Finds (1) that the amount of the share capital of the said Collectivworks Limited paid up or credited as paid up does not exceed £120,000; (2) that the said company is unable to pay its debts;

therefore Orders that the said company, Collectivworks Limited, a company incorporated under the Companies Act (SC331155) and having its registered office at The Printworks, 10 Otago Street, Glasgow, Scotland, G12 8JH be wound up in pursuance of the Insolvency Act, 1986; Nominates and Appoints Ian William Wright, Insolvency Practitioner, Quantuma LLP, 3rd Floor, Turnberry House, 175 West George Street, Glasgow, G2 2LB to be the Interim Liquidator of the said company with the usual powers, all in terms of said Statute and of Law; Finds the petitioner entitled to the expenses of this application and Directs same to be expenses in the liquidation.
