On 12 August 2020, a notice was published in the Edinburgh Gazette requiring creditors to prove their claims by 25 September 2020. No creditors were forthcoming as a result of this notice.

It has been agreed that the costs of executing the liquidation are to be met by a third party, to whom I will write, under a separate cover, with my invoice on account for acting as liquidator of the Company.

Disbursements have been incurred in relation to statutory advertising and bonding. These will be invoiced to the third party.
