Introduction

The Directors, who are the charity trustees for the purposes of Charity Law, have pleasure in presenting their annual report and accounts for the year ended 31st December 2014.

The directors are satisfied with the performance of the charity during the year and the position at 31st December 2014 and consider that the charity is in a strong position to continue its activities during the coming year, and that the charity's assets are adequate to fulfil its obligations.

Objectives and Activities of the Charity

Summary of main activities of the charity in relation to its objects

The objectives of the charity are to advance the education and participation of young people in Scotland in the subjects of music, creative art, creative writing and sport (currently Taekwondo and football) by providing and assisting in the provision of tuition and facilities (not required to be provided by the local education authority) for such education and participation.

Falkirk Area

Larbert High School, Kiran's former secondary school, continues to be an outlet for Kiran's Trust to support creative arts education. Three school prizes are awarded each year: creative design, music, and creative writing. A three year scholarship is also awarded to support a creative design/art pupil from their fourth year onwards (monies increase each year through to sixth with the potential to assist if students go on to study design/art at college.) The current scholarship recipient is in her fourth year of school.

Falkirk Area (cont)

Support was continued for Carrongrange School, as well as several primary schools in the area.

While the relationship with Delta Art Studio continues, no monies were paid in 2014 as the staff were developing other ways to engage and promote artistic activity. This will be detailed in the 2015 report.

Central Taekwondo Academy, where Kiran trained and competed, is where we support young people in their advancement in the sport of Taekwondo. The three scholarships continue under the designations of 'sustaining' and 'developing'. The Kiran Martin Indomitable Spirit Prize is awarded annually to recognise an individual committed to the sport of Taekwondo but who does not participate at a competition level. We support Asia Bailey in the Elite Athletes programme for Team GB as she prepares for the 2016 Olympics in Rio. As part of this sponsorship, Asia will promote Kiran's Trust in her training for national and international competitions.

Fife/Pittenweem Area

This year Pittenweem Primary School awarded the annual creative prize to a student selected by school staff, the recipient was chosen for his artwork and creative writing.

We continue to support the Fife Society for the Blind in their efforts to use creative art as an educational and inclusion tool.

Kiran's Trust hosted a venue at the Pittenweem Arts Festival where our art scholars from Falkirk, Pittenweem, and Edinburgh showcased their work.

Edinburgh Area

A few opportunities for the area commenced in 2014. We provided funding for a World Cup event with 3V2 Soccer Academy who provide football training for young girls and boys. We formed a partnership with Space Artworks - a gallery that holds various skills workshops and supports individuals with disabilities.

National

In conjunction with Taekwondo Scotland, we sponsored the People's Choice Award at their annual awards ceremony.

Achievements and Performance of the Charity

Summary of the main achievements of the charity during the year

The outgoing Larbert High Scholarship recipient successfully enrolled in Art College and received £300. The third Kiran Martin Art Scholarship winner received her first payment of £100. Prizes of £50, along with trophies (valued at £33 each), were awarded at Larbert High School's summer prize giving for each of the following categories: creative design, music and creative writing.

Carrongrange School received £200 to help host The Young Americans, who promote music education and performance. With the assistance of Karen McCabe, the following Primary Schools were awarded monies for creative arts and physical education activities: Westquarter, Laurieston, Nethermains, Stenhousemuir, and Bonnybridge.

The Kiran Martin Taekwondo Scholarships at Central Taekwondo Academy were paid out at £300 for sustaining (one recipient) and £300 for developing (two recipients of £150 each). The Kiran Martin Indomitable Spirit Prize was awarded (£50 to spend on Taekwondo equipment) along with an engraved nameplate for the trophy (donated by LECS upholstery). Asia Bailey received a £1,000 sponsorship for her 2016 Olympics preparations.

The creative prize (£50) was awarded at Pittenweem Primary School.

The sponsorship of the Pittenweem Arts Festival totalled £400, and our scholars received proceeds of £160 for the sale of their work.

Fife Society for the Blind received £300 for Bookbug sessions for young people with sight impairment and their parents. This included the use of musical instruments to help interpret the stories.

3V2 Soccer Academy received £200 for their World Cup event.

Space Artworks received £400 to assist with exhibitions and publicity.

The People's Choice Award (a trophy valued at £75) was awarded through Taekwondo Scotland to an athlete chosen by their peers and coaches as the individual who demonstrated the best discipline and performance for the year.

In 2014, we had 20 friends (a minimum of £10 donation), of which 5 make a monthly payment to Kiran's Trust. Friends were given notecards featuring Kiran's own artwork as a token of appreciation. The reminder date for renewal is 9 October.

We now have six different Christmas card designs created by recipients of Kiran's Trust support. They continue to be a good fundraiser, with over £290 raised, and it gives the scholars an opportunity for displaying their artwork.

The directors recognise the importance of diversifying the ways in which we raise funds, especially with continued financial pressures on individuals. There is a Kiran's Trust 'shop' on eBay, where we sell new or second hand items donated to us. For the year, the amount raised was £135. Kiran's Trust is also actively promoting the use of www.easyfundraising.co.uk as a way for people to support while doing their normal online shopping.

The Kiran's Trust website (www.kiranstrust.org) has undergone a modernisation and still provides information regarding the charity, about Kiran (and some of her artwork), objectives and funding, upcoming fundraising events and access to newsletters and company reports. Additional information outlets are provided via direct mail/email of newsletters, Facebook, Twitter, and Instagram.

The directors express their gratitude to the many individuals who became Friends, made donations, attended and /or supported fundraising events. The directors wish to acknowledge the special efforts of Martin Spence and Adam Pender for their organisation of the karting fundraiser; Emma Phillips, Jillian McDonald, Laurie Risk, and Deborah Campbell for their Colour Me Rad fundraiser; Jordyn Smith for her lead on OperationSmarties; and lastly Pat Kramek for the donation of a framed print for raffle and everyone who donated a portion of their sales from the Pittenweem Arts Festival - the "professionals" (Moraig Page and Mahri Ivey) and the scholars (Sam Mutch, Meghan Grieve, Caitlin MacInnes, Maisie Cotter, and Beth Rundle). The directors also wish to acknowledge Ele Erskine, Victoria Nicholson, Sam Mutch, Edina Donald, Meghan Grieve and the parents of Esme McIntyre for their donation of artwork to produce Christmas cards for sale to the benefit of Kiran's Trust. Thanks are also extended to the following companies for their donations, services and prizes to the benefit of fundraising events or awards: Central Taekwondo, LECS Upholstery, Xtreme Karting, Certas Energy, The Salon, and Parc Hair and Beauty (in Falkirk area); Wm Christie and Sons, Montpeliers of Bruntsfield, Cork and Cask (in Edinburgh); Mark Holden Art ;BP Safety Reps and the Andrew and Clair platforms.

Structure, Governance and Management

Nature of the Governing Document and constitution of the charity

Kiran's Trust is a company limited by guarantee, and is governed by the regulations set out in the memorandum and articles of association, incorporated on 15 September 2009, and is recognised as a charity by the Office of the Scottish Charity Regulator.

The directors meet a minimum of twice a year to conduct the business of Kiran's Trust. The directors, on behalf of Kiran's Trust, award prizes and scholarships in the area of creative arts-design, music and writing, and for participation in Taekwondo. The recipients are selected by the administrative staff among those organisations to which Kiran's Trust provides support.

Training of Directors/Trustees

Directors' training in developments affecting the charity's areas of activity is addressed as part of the directors' meetings.

All directors are familiar with the work of the charity. If there are any areas where additional training is required this would be discussed at a directors' meeting and a suitable solution identified.

The major risks to which the charity is exposed and reviews and systems to mitigate risks

The directors have assessed the major risks to which the charity is exposed, in particular those related to the operation and finances of the charity, and are satisfied that systems are in place to mitigate their exposure.

Availability and adequacy of assets of each of the funds

The board of trustees is satisfied that the charity's assets in each fund are available and adequate to fulfil its obligations in respect of each fund.

Transactions and Financial position

The financial statements are set out on pages 10 to 15. As stated in the introduction to this report, the trustees consider the financial performance by the charity during the year to have been satisfactory.

The Statement of Financial Activities show net incoming resources for the year of £9,244 (prior year £10,132). The resources expended were £6,926 (prior year £5,349), giving a surplus of £2,318 (prior year £4,783).

The total reserves at the year end stand at £29,901 (prior year £27,583).

Free unrestricted reserves amounted to £25,026 (prior year £22,708). These reserves are held to ensure that the company's commitments to their scholarships and prizes are able to be fulfilled until such time as additional funding can be put in place.

The designated reserves amounted to £4,875 (prior year £4,875). These are set aside for use during the next financial year to ensure that commitments are met.

Share Capital

The company is limited by guarantee and therefore has no share capital.

They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

The trustees are also responsible for the contents of the trustees' report, and the responsibility of the independent examiner in relation to the trustees' report is limited to examining the report and ensuring that, on the face of the report, there are no inconsistencies with the figures disclosed in the financial statements.

Method of preparation of accounts

These accounts have been prepared in accordance with the provisions applicable to companies subject to the small companies regime.

I report on the financial statements of the Charity on pages 10 to 15 for the year ended 31 December 2014 which have been prepared in accordance with the Charities and Trustee Investment (Scotland) Act 2005 (The 2005 Act) and the Charities Accounts (Scotland) Regulations 2006 (The 2006 Accounts Regulations) and with the Financial Reporting Standard for Smaller Entities (FRSSE), effective April 2008, as modified by the Statement of Recommended Practice for Accounting and Reporting, effective April 2005 as modified in May 2008. (The SORP), under the historical cost convention and the accounting policies set out on page 12.

Respective responsibilities of trustees and examiner

The Charity's trustees, who are also the directors of the company for the purposes of company law, are responsible for the preparation of the accounts in accordance with the terms of The 2005 Act and The 2006 Accounts Regulations.

The charity trustees consider that the audit requirement of Regulation 10(1) (a) to (c) The 2006 Accounts Regulations does not apply.

Having satisfied myself that the charity is not subject to audit under company or charity law, or otherwise, and is eligible for independent examination, it is my responsibility to examine the accounts as required under section 44(1) (c) of The 2005 Act and to state whether particular matters have come to my attention.

Basis of opinion and scope of work undertaken

I conducted my examination in accordance with Regulation 11 of The 2006 Accounts Regulations. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters.

The procedures undertaken do not provide all the evidence that would be required in an audit, and information supplied by the trustees in the course of the examination is not subjected to audit tests or enquiries, and consequently I do not express an audit opinion on the view given by the financial statements, and in particular, I express no opinion as to whether the financial statements give a true and fair view of the affairs of the charity, and my report is limited to the matters set out in the statement below.

1 Accounting policies

Basis of preparation of the accounts

The financial statements have been prepared in accordance with the Statement of Recommended Practice, Accounting and Reporting by Charities (Revised 2005), applicable accounting standards and the Companies Act 2006.

The company has taken advantage of the exemption in Financial Reporting Standard No 1 from the requirement to produce a cash flow statement, on the grounds that it is a small company.

Accounting convention

The financial statements are prepared, on a going concern basis, under the historical cost convention.

Incoming Resources and resources expended

Incoming resources are accounted for on a receivable basis.

Resources expended are recognised in the period in which they are incurred.

Governance costs include the general running expenses of the company and consist mainly of those relating to statutory requirements.

Investment Income

Bank Interest received is included on an actual receipts basis.

Taxation

As a registered charity, the company is exempt from income and corporation tax to the extent that its income and gains are applicable to charitable purposes only. Value Added Tax is not recoverable by the company, and is therefore included in the relevant costs in the Statement of Financial Activities.

Funds structure policy

Funds are classified as either restricted or unrestricted funds, defined as follows:

The charity maintains a general unrestricted fund which represents funds which are expendable at the discretion of the trustees in furtherance of the objects of the charity. If parts of the unrestricted funds are earmarked at the discretion of the trustees for a particular purpose, they are designated as a separate fund. This designation has an administrative purpose only and does not legally restrict the directors' discretion to apply the fund.

There is no formal policy of transfer between funds or on the allocation of funds to designated funds, other than that described above.

2 Winding up or dissolution of the charity

If upon winding up or dissolution of the charity there remain any assets, after the satisfaction of all debts and liabilities, the assets represented by the accumulated fund shall be transferred to some other charitable body or bodies having similar objects to the charity.
