The sheriff, having resumed consideration of the foregoing petition together with the productions produced, and having seen the Edinburgh Gazette dated 19 March 2019 and the Metro newspaper dated 21 March 2019 each containing the intimation ordered by the preceding interlocutor, no answers to said petition having been lodged in court, Finds (1) that the amount of the share capital of the said Earthy Aston Leisure Limited, a company incorporated under the Companies Acts (Company Number SC443643) paid up or credited as paid up does not exceed £120,000; (2) that the said company is unable to pay its debts;

therefore Orders that the said company, having its registered office at 1 Gardenfield, Nine Mile Burn, Penicuik, Midlothian, EH26 9LT, be wound up in pursuance of the Insolvency Act, 1986; Nominates and Appoints Keith Anderson of MLM CPD LTD trading as MLM Solutions, 14-18 Hill Street, Edinburgh, EH2 3JZ, to be the interim liquidator of the said company with the usual powers, all in terms of said Statute and of Law; Finds the petitioner entitled to the expenses of this application and Directs same to be expenses in the liquidation.
