1. Accounting policies

Basis of accounting

The financial statements have been prepared under the historical cost convention, and in accordance with applicable UK accounting standards.

Turnover

The company leases market stalls to tenants. income is recognised at the amount received or receivable net of discounts and is recognised in the period of lease.
