

The Sheriff, having resumed consideration of the foregoing petition together with the productions produced, and having seen the Edinburgh Gazette dated 1 July 2022 and the Herald newspaper dated 5 July 2022 each containing the intimation ordered by the preceding interlocutor, no answers to said petition having been lodged in court, Finds (1) that the amount of the share capital of the said MSM GLOBAL LTD, a company incorporated under the Companies Acts (Company number SC469595) and having its registered office at 1 Eagle Street, Glasgow, Scotland, G4 9XA paid up or credited as paid up does not exceed £120,000; (2) that the said company is unable to pay its debts;

therefore Orders that the said company, MSM GLOBAL LTD, a company incorporated under the Companies Acts (Company number SC469595) and having its registered office at 1 Eagle Street, Glasgow, Scotland, G4 9XA be wound up in pursuance of the Insolvency Act, 1986; Nominates and Appoints Mark Harper and Steven John Parker, both of Opus Restructuring LLP, Fourth Floor, Euston House, 24 Eversholt Street, London NW1 1DB to be the Joint interim liquidators of the said company with the usual powers, all in terms of said Statute and of Law; Finds the petitioner entitled to the expenses of this application and Directs same to be expenses in the liquidation.
