In the wake of the Covid-19 pandemic, our 7th year has seen a shift in working patterns and ways of genuinely undertaking co-design and community engagement. With social sustainability a priority outcome, and communities valuing an active role in the design and management of local green spaces, we have decided over the course of the projects undertaken this year to shift away from offering an engagement / co-design facilitation team, to a focus on capacity building.

HERE+NOW was never set up for online engagement, and neither do we promote it because putting all engagement / consultation onto website / online surveys / social media excludes a considerable demographic and is therefore not inclusive or genuine.

With a view to capacity building Liz Thomas, the sole director, has decided to step down from the CIC and focus on offering services with an up-skilling / training approach.

Therefore, the activity of HERE+NOW CIC wound down over the second half of 2021, transferring the skills to other organisations we have collaborated with such as the Edinburgh & Lothians Greenspace Trust and the Water of Leith Conservation Trust. Time was spent in developing ways to make project processes which aren't dependent on external facilitation, as a way to hand over / legacy the work of HERE+NOW.

Over the course of the 2021 reporting year, it was decided to wind down the CIC and Liz piloted a different way of working which was based on using external organisations - usually already on the ground or active in a given project or location - as the facilitating team. Liz would design the project process and approach, but hand over autonomy and facilitation to the active partners, thus ensuring long term and further reaching social sustainability.

Therefore, the function of the CIC has reached a natural conclusion, and HERE+NOW CIC is no longer active.
