

The sheriff, having resumed consideration of the petition together with the productions produced, and having seen the Edinburgh Gazette dated 22 October 2019 and the Dunfermline Press newspaper dated 24 October 2019 each containing the intimation ordered by the preceding interlocutor, no answers to said petition having been lodged in court, Finds (1) that the amount of the share capital of the said MBC CLADDING LIMITED paid up or credited as paid up does not exceed £120,000; (2) that the said company is unable to pay its debts; therefore Orders that the said company, having its registered office at 71 Craigside Road, Cardenden, Lochgelly, KY5 0JX be wound up in pursuance of the Insolvency Act, 1986; Nominates and Appoints Bryce Luke Findlay, 50 Darnley Street, Pollokshields, Glasgow, G41 2SE to be the interim liquidator of the said company with the usual powers, all in terms of said Statute and of Law; Finds the petitioner entitled to the expenses of this application and Directs same to be expenses in the liquidation.
