



INTRODUCTION

The following information details the progress of the winding up in the period from 7 November 2021 to 3 May 2022 in accordance with Rule 7.4 of the Insolvency (Scotland) (Receivership and Winding up) Rules 2018. This report should be read in conjunction with any previous reports.

ACTIONS TAKEN BY LIQUIDATOR

I have attended to all statutory matters and administrative tasks that have arisen during the period including providing update reports to the creditors, the review of bordereau and case progression, reconciliation of the liquidation bank account, preparation and submission of VAT and Corporation Tax Returns and all other administrative actions as required.

RECEIPTS & PAYMENTS

An abstract of my receipts and payments for the period 7 November 2021 to 3 May 2022 is attached.

ASSET REALISATION

To date there have been no realisations in this case. The costs of the Liquidation have been met by the petitioning creditor.

PREFERENTIAL CLAIMS

There were no employees at the date of liquidation and there will be no preferential claims. There has been no dividend paid to preferential creditors.

FLOATING CHARGE CREDITORS AND THE PRESCRIBED PART

Section 176A of the Insolvency Act 1986 requires me to set aside a prescribed amount of the Company's net property towards the satisfaction of unsecured creditors. Net property is the amount that would otherwise be available to satisfy the holders of any floating charge created by the Company after 15 September 2003. There is no Floating Charge Holder registered and therefore the prescribed part therefore does not apply.

UNSECURED CLAIMS

Unsecured claims totalling £80,691.93 have been received in the Liquidation. There has been no dividend paid to unsecured creditors. There will be insufficient funds available for a dividend to unsecured creditors in this case.

LIQUIDATOR'S FEES

A SIP9 summarising the time costs accrued for the period 7 November 2021 to 3 May 2022 is attached. Total time costs for the period were £598.00. My fee is based on reference to the work which has been reasonably undertaken by myself and my staff in matters arising in the winding up. No fees have been approved or drawn in this accounting period and no application is to be made to the Court in respect of the period in hand. GENERAL

Given all matters in the Liquidation have now been concluded, the Liquidator will vacate office as soon as he has filed the final account and notice confirming whether any creditors have objected to the liquidator's release. This must be filed with the Court, the Registrar of Companies, the Accountant in Bankruptcy and the Accountant of Court. The liquidator will be released at the same time unless any of the creditors object to the release.
