3. OTHER FINANCIAL COMMITMENTS

The company has entered into a vehicle hire agreement for a Isuzu D Max van. The agreement commenced on 15 June 2021 and is scheduled to run for three years. Under the terms of the agreement the company has a commitment for further hire payments of £4,116 to complete the full agreement term.

The company is entitled to exemption from audit under Section 477 of the Companies Act 2006 for the year ended 31 July 2023.
