The Sheriff, having resumed consideration of the foregoing petition together with the productions produced, and having seen the Edinburgh Gazette dated 24 October 2022 and the Herald newspaper dated 24 October 2022 each containing the intimation ordered by the preceding interlocutor, no Answers to said petition having been lodged in court, Finds (1) that the amount of the share capital of the said All Utility Solutions Limited, a Company incorporated under the Companies Act under Company Number SC545548, having its registered office at Garrowhill Business Centre s, 68 Whirlow Road , Baillieston, Glasgow, G69 6QE paid up or credited as paid up does not exceed £120,000; (2) that the said company is unable to pay its debts;

therefore Orders that the said company, All Utility Solutions Limited, a Company incorporated under the Companies Act under Company Number SC545548, having its registered office at Garrowhill Business Centre s, 68 Whirlow Road, Baillieston, Glasgow, G69 6QE be wound up in pursuance of the Insolvency Act, 1986; Nominates and Appoints Blair Carnegie Nimmo and Geoffrey Isaac Jacobs of Interpath Limited, 130 St Vincent Street, Glasgow G2 5AF to be the interim liquidators of the said company with the usual powers, all in terms of said Statute and of Law; Finds the petitioner entitled to the expenses of this application and Directs same to be expenses in the liquidation.
