

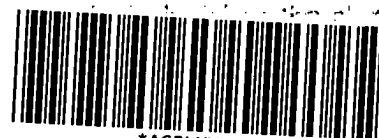

The Sheriff, having resumed consideration of the foregoing petition together with the productions produced, and having seen the Edinburgh Gazette dated 6 October 2023 and the Scotsman newspaper dated 5 October 2023 each containing the intimation ordered by the preceding interlocutor, no answers to said petition having been lodged in court, Finds (1) that the amount of the share capital of the said CLUBHOUSE BARS LIMITED having its Registered Office at 130 Main Street, East Calder, Livingston, EH53 0HD paid up or credited as paid up does not exceed £120,000; (2) that the said company is unable to pay its debts;

therefore Orders that the said company, having its registered office at 130 Main Street, East Calder, Livingston, EH53 0HD be wound up in pursuance of the Insolvency Act, 1986; Nominates and Appoints Christopher David Horner, 47-49 Duke Street, Darlington, County Durham, DL3 7SD to be the interim liquidator of the said company with the usual powers, all in terms of said Statute and of Law; Finds the petitioner entitled to the expenses of this application and Directs same to be expenses in the liquidation.
