

The Lord Ordinary, having resumed consideration of the petition and proceedings, no answers having been lodged,

1. orders Hancock Scotland Limited, a company incorporated under the Companies Acts (with company number (SC591337) (the "Company") to be wound up under the provisions of the Insolvency Act 1986;
2. nominates and appoints Stuart Charles Robb and Callum Angus Carmichael both of FRP Advisory Trading Limited, Level 2, The Beacon, 176 St Vincent Street, Glasgow, G2 5SG both duly qualified under the 1986 Act, to be joint *interim* liquidators of said company and authorises them to exercise the powers contained in Part II of Schedule 4 to the 1986 Act;
3. declares in terms of Section 231 of the Insolvency Act 1986 that any act required or authorised by any enactment be done by either of the joint *interim* liquidators;
4. finds the expenses of and incidental to this application and the procedure to follow hereon, to be expenses in the liquidation;
5. appoints the clerk of court to send a copy of this order forthwith to each of the said joint *interim* liquidators;
6. appoints each of the joint *interim* liquidators to give notice of their appointment in terms of Rule 5.21 of the Insolvency (Scotland) (Receivership and Winding up) Rules 2018.
