### Company activities and impact

The company continues to maintain, operate and develop RecipeRadar ( <https://www.reciperadar.com> ), a free and open source recipe search engine with accompanying meal planning tools. For the reporting period December 2021 to November 2022, web traffic on RecipeRadar was slightly decreased compared to the previous reporting period, at approximately 4,750 searches. The company contributed to community open source projects including continuation of development of "recipe-scrappers", a library to extract recipe-related metadata from the web, and also "select2", a user interface component designed to provide advanced and accessible web input selection functionality. No additional hardware purchases were required for the continued operation of RecipeRadar during the reporting period. Service continued to be provided to the general public at no cost.
