## LIMITED PARTNERSHIP

On behalf of The Grampian Regional Council I hereby offer to enter into a limited partnership with you, A Groat, Marnon wells, Turriff, on the following terms and conditions:-

- 1. The partnership shall be a limited partnership in terms of the Limited Partnerships Act 1907. You will be the general partner of the firm and the Council will be a limited partner within the meaning of the Act. The general partner will be responsible for the whole management of the firm's business and afrairs including without prejudice to that generality the fulfilment of the firm's obligations under the Lease hereinafter mentioned and compliance with any statutory requirements relating to the firm. The general partner will be liable for all debts and obligations of the firm including without prejudics to that generality the costs of registering the same as a limitar partnership in terms of the said Act and will receive all profits arising one of the Specialism of the business of the firm.
- 2. The term or the partnership shall be the period from the conclusion of missives until 28 November, 1990, and thereafter the partnership shall continue on a year to year basis subject to Condition 4 hereof.
- 3. The firm name shall be A Groat and Grampian Regional Council and the principal place or business shall be Marnon Wells, Turritr.
- 4. The limited partner will be entitled to dissolve the partnership at any time upon giving to the general partner not less than three months prior written notice.
