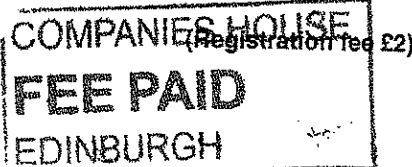





## NOTES
