Previous term

The Partnership shall continue until dissolved with the agreement of the partners.

New term

The Partnership Agreement, as amended and restated on 7 OCTOBER 2011, provides that, subject to earlier termination (see below), the Partnership shall continue until the expiry of 10 years from the first closing date of the Partnership provided, however, that the life of the Partnership may be extended by up to three additional one year periods at the discretion of the manager, with the first such extension requiring the approval of the Partnership's Advisory Committee and the subsequent two such extensions requiring the approval of certain limited partners as more particularly described in the Partnership Agreement.

The life of the Partnership shall be sooner terminated upon the happening of any of the following events:

- (i) the bankruptcy, insolvency, expulsion, dissolution, liquidation, removal or voluntary withdrawal of the general partner;
- (ii) the agreement as to such termination of the partners;
- (iii) the removal of the general partner by certain of the limited partners in accordance with their rights to do so as more particularly described in the Partnership Agreement; or
- (iv) the Manager ceasing to be an authorised person under the Financial Services and Markets Act 2000 subject to certain provisos more particularly described in the Partnership Agreement.


