

2. the entry of a decree of judicial dissolution of the Partnership pursuant to section 35 of the Partnership Act 1890;
3. subject to the terms of the agreement constituting the Partnership from time to time (the "Partnership Agreement"), the bankruptcy or dissolution of the General Partner or the occurrence of any other event that causes the General Partner to cease to be the general partner of the Partnership;
4. the last day of the calendar quarter in which the twelfth (12th) anniversary of the Final Closing (as such term is defined in the Partnership Agreement) provided that unless an Event of Dissolution set forth in paragraphs 1-3 above occurs, the General Partner shall be permitted in its sole discretion to continue the Partnership for up to three successive one-year periods.


