

1. GENERAL INFORMATION AND BASIS OF ACCOUNTING

Addleshaw Goddard (Scotland) LLP is a limited liability partnership incorporated in Scotland, within the United Kingdom. The address of the registered office is given on page 1.

The financial statements have been prepared under the historical cost convention in accordance with the Financial Reporting Standard 102 Section 1A – The Financial Reporting Standard applicable in the UK and Republic of Ireland and the Companies Act 2006 and in accordance with the Statement of Recommended Practice 'Accounting Limited Liability Partnerships issued in December 2018.

The financial statements are prepared in sterling which is the functional currency of the LLP.

The LLP was dormant and has not traded in the year.
